This written consent was required at the time, prior to the permit being issued.

Development Plan Overlay control (Schedule 7 – Tenterfield)	Clause 43.04 of the Melton Planning Scheme requires that prior to a planning permit being issued for any use, development or subdivision, a development plan for the land must be prepared to the satisfaction of the Responsible Authority.
	A development plan for the Tenterfield subdivision was approved on 14 November 2002 in accordance with this overlay control, and identifies the land as being use and developed for the purpose of district open space.
