# 6.1 NDIS

# Samantha Hein, Community and Mainstream Engagement Victoria and Tasmania, NDIA

S Hein had a presentation to view with handouts.

The National Disability Insurance Scheme (NDIS) has been in effect since 1 October 2018. The NDIS is a nation-wide program that will deliver services and support to people with permanent and significant disability in Australia. Income support will not be effected by the NDIS, it is also not means-tested.

Brimbank Melton local area NDIS partner is the Brotherhood of St Laurence. S Hein explained that parents, carers and professionals of children aged 0-6 can refer and discuss concerns and look at appropriate pathways. Children do not need a diagnosis to access support. When appropriate, an access request form need to be completed to transition to the NDIS.

Discussion was held around registered and unregistered providers, families having a choice of providers, and their ability to navigate these reforms, especially those from CALD communities and more vulnerable families. The NDIA are aware of barriers to access the NDIS and have organised community sessions to support families, and are encouraging feedback from stakeholders.
