### 6.1. Melton History Project

History of Melton Project is nearing completion and permission has been received to use the first section of this work as a resource on First Nation's history.

# 7.1 KIRRIP update

Kirrip and DHHS are working towards increasing management of targeted funding to be administered through Aboriginal organisations.

Traineeship Program funding is being sought by Kirrip through DHHS for up to three years.

Deadly Race program, as an activity of NAIDOC across the Western Region, will occur in November and will be coordinated by Kirrip.

Ongoing service delivery of specialist services via outreach to Kirrip including; Youth, Family and Health and Wellbeing continuing.

"Bubba Grub" (Salvation Army funded nutritional food program) has been established at KIRRIP. Communal cooking produces between 30 and 50 ready to eat meals for distribution as emergency relief support for children and Elders.

As part of NAIDOC week in partnership with Djerriwarrh Health there will be a cultural day.

# 7.2 Djirra (previously Family Violence Prevention Legal Service) update

Wanda reported that plans are underway to open an additional four offices, Geelong, Shepparton and Warnambool are confirmed. The fourth will be in the western suburbs but has yet to be decided upon. This will be a Family Violence Service that primarily supports Indigenous women.

Sister's Day events are also in high demand and planned for later in the year.

Women's Place now open in the metro area with regional services to follow.

# 7.3 Young Minds Matter

Cr Lara Carli promoted the Young Minds Matter – Youth Mental Health forum for young people 12 years plus and their families. This is a Councillor initiative and will be held on 19/04/18 from 5.00 to 8.30 pm at the Catholic Regional College in Bullmans Road, Melton.
