6.1 Welcome to Hope Street Youth and Family Services

L Smith welcomed N Vella and T Tregea from Hope Street Youth and Family Services to the Committee.

6.2 Victoria Police narrative: attending a family violence incident

K Anderson shared the most recent local family violence statistics, highlighting the recent serious incidents in Diggers Rest. He then provided a narrative of a de-identified family violence case to illustrate the risk assessment process and Victoria Police's role.

Cr De Santis asked what work could be done in the early years to tackle the issue. J Eddy spoke about the rollout of Respectful Relationships education through the Department of Education and Training and noted that the Foundation level curriculum is suitable for early years. S Grace informed the Committee that gender equity professional development training for early years workers is being delivered by Council on 2 May 2018.

G Ludbrook shared what the legal process is that follows Police intervention in a family violence incident. He raised that unfortunately legal aid is not available to support clients with issues such as property settlements that may be part of a family violence case.

T La Fontaine spoke about a positive partnership between Women's Health West and the Women's Legal Service Victoria in recognition of the legal challenges associated with family violence.

Cr Ramsey, in response to K Anderson's narrative, enquired about the wellbeing of Victoria Police. K Rudkins explained that support and debriefing is available to Police Officers.

6.3 Support and Safety Hub advocacy

M Wilson explained that there is limited information at this stage surrounding the Support and Safety Hub for the Brimbank Melton region. The pilot sites are currently being implemented in other regions and DHHS is watching closely to learn from their experience.

M Wilson also spoke about the possible future projects regarding women's refuges. Nineteen refuges will be delivered across Melbourne by the state government and one of those will be in the Brimbank Melton region. There are ongoing conversations about one being located in the City of Melton and M Wilson's team is working diligently to provide traction.

Discussions have also taken place with the Department of Housing in regards to the Family Violence Housing Fund. The entirety of the fund was committed very quickly and M Wilson is awaiting further budgetary announcements to continue advocacy around family violence housing in the City of Melton.

Cr Ramsey queried the system for deciding on Support and Safety Hub locations. M D'Elia explained that each of the 17 Department of Health and Human Services regions will be allocated one Hub. M D'Elia also spoke about how the staffing, intake and information sharing processes at the Hubs may work.

Cr Carli requested that an invitation be sent to Minister Natalie Hutchins as soon as possible to attend a future Committee meeting.

6.4 Equality and Respect 2030 Strategy

L Smith provided an update on Council's *Equality and Respect 2030: A Strategy to prevent violence against women by promoting gender equity in the City of Melton.* She thanked Committee members who provided feedback on the draft Strategy and explained that the draft had gone to a Councillor Briefing on 9 April and would be presented to Council for adoption at the Ordinary Council Meeting on 30 April.
