MM made a presentation on the different State Government departments and agencies, and which parts of the transport system in Victoria they manage (refer **Attachment 1**).

4.3 Management of the local transport network in the City of Melton (presented by KW)

KW presented an overview on the management of the local transport network, which included information on:

- · Speeding complaints and investigations
- Road safety design
- Parking issues
- · Signs and linemarking

KW then walked the MTCRG through the Roads and Traffic webpage on Council's website. http://www.melton.vic.gov.au/Services/Building-Planning-Transport/Roads-and-traffic

The MTCRG members were encouraged to look at the information on Council's website, which provides information on how Council manages roads and traffic in the City of Melton.

MM provided details on some of the transport champions in Victoria, which are advocating for the improvement of transport modes across Victoria (refer **Attachment 2**):

DO noted that there is an additional group which are active in the City of Melton, the Calder Action Group, which are a community based action group focused on the improvement of the Calder Highway in the vicinity of Calder Park Drive.

Action

4.5 Moving Melton advocacy action

General discussion was held on the importance of community based advocacy, and the types of advocacy campaigns that could be run particularly in the lead up to the State election in November 2018.

Discussion was held on some of the transport problems that we face in the City of Melton relating to the public transport system and arterial roads. It was agreed that there is much room for improvement with our current bus, rail and arterial road systems to better manage current demand, and to cater for future demand with the projected increase in population.

Discussion was held that once the MTCRG has identified its top priority (priorities) that it may be efficient to partner with an existing advocacy campaign being run by one of the aforementioned transport champions or advocacy groups in Section 4.4 above.

It was agreed that the MTCRG members will look at *Moving Melton* and the *City of Melton Advocacy Priorities*, and pick their top two items to be actioned. If there is common ground on those actions, they will be the matters the MTCRG will advocate for in the short term.

It was requested that MM look into having guest speakers in the future from transport providers or advocacy groups. Suggestions included the operators of Melbourne Airport, or LeadWest. It was requested that no speakers be sought for the next meeting in June, as this will be focussed on identifying the MTCRG's priorities for action. MM requested MTCRG members email him suggestions for speakers, and contacts for speakers.

Action

MTCRG members to review the actions in *Moving Melton* (Council's Integrated Transport Strategy) and the *City of Melton Advocacy Priorities*, and identify their top two actions for the next meeting to be held on Tuesday, 26 June 2018.

MTCRG members to email MM suggestions for guest speakers for future meetings.

- Includes all six local governments in Melbourne's West and they are joined by major companies and other organisations, each with substantial operations or interests that are based in Melbourne's west.
- Advocates for improvements to education and skills, the regional economy, health and wellbeing, environment and liveability, transport and infrastructure, and experience and enjoyment.
- Advocacy for transport issues via the Western Transport Alliance.

- Number two priority is additional traffic lanes Melton Highway to Keilor Park Drive
