## 6.3.2 Victoria Police

C Stuhldreier shared the current City of Melton road statistics for the year to date. He reported that there were three fatalities over January – February which has since slowed with six fatalities for the past 12 months. An average of 6-8 fatalities/year indicates a 20 per cent increase. Serious injury collisions have reduced by 32 per cent from 63 last year down to 44. Minor collisions are slightly up.

C Stuhldreier reported impounds have increased by 71 per cent.

C Stuhldreier noted that Victoria Police is coming in to busy period for targeting road safety:

- Operation Argus (5 8 September) to coincide with AFL finals
- Operation Scoreboard (26 29 September) for AFL Grand Final long weekend
- Operation Furlong (early November) for Spring Carnival

C Stuhldreier reported a statewide focus on drug testing of drivers.

Discussion around Boundary Rd/Hopkins Road intersection blackspot and road safety concern.

K Leech not present however provided following report tabled by J McArdle:

Nine new mentors being trained on Saturday, 7 September at Djerriwarrh Community and Education Services (DCES) Melton, recruited from Sons of the West workshop where new L2P promotional video was screened.

Promotional video was shown at Bacchus Marsh Rotary resulting in a cash donation. The video is on loop in Melton Toyota waiting room with their vehicle videos.

Quarterly Statistics - 48 learners on the road, seven licenses, 744 drive hours and 28 active mentors. There have been a total 152 licenses achieved through the program. Thirty learners are currently on the waitlist.

The L2P program is now branded as TAC L2P. Vehicles and media information will be rebranded over the next six months accordingly.

Still working towards replacing old L2P vehicle in Melton. M Wilson reported that Melton City Council's Community Funding and Projects Officer is looking at grant opportunities.

## 7.1 Street lighting concern

M Wilson raised concern regarding the delay in switching on street and traffic lights after installation. Street lights are constructed and installed, often by Council or VicRoads, however commissioning by Powercor can be delayed for some time post-installation. Unlit lights can create a community safety and road safety concern. Cr Carli reported that Council CEO, Kelvin Tori, sent a letter to Powercor on behalf of Council regarding issue and particularly Westwood Drive Bridge following fatality.
