4. Djerriwarrh Health Services strategic planning engagement

B Scott and A Agius provided an overview of the process being undertaken for Djerriwarrh Health Services to develop its 5 year Strategic Plan. As part of the process a Strategic Planning Steering Committee has been formed with representatives from Melton, Bacchus Marsh, Department of Health and Human Services and consumers. Extensive community consultation has been planned. The aim is to have the Strategic Plan completed by June 2019.

The consultation provides for feedback on two key questions:

- What are the three most important things to you when you think about healthcare services?
- What services are required for people with additional needs within our catchment?

5. Pierre Gorman Award update

S Prestney provided the following update on the Pierre Gorman Award project:

- All 15 library services who are part of the Project Working Group have signed up as affiliates of the American based program, 'Next Chapter Book Club'.
- Melton City Libraries coordinated their affiliation which was paid via the Pierre Gorman scholarship funding.
- In February, the project sponsored Nicola Grove from UK organisation, Open Story Tellers to provide training for disability engagement and conducting multisensory story sharing sessions. The two day training explored ways in which Libraries could make literature more accessible for people with learning disabilities.
- The training has equipped each organisation with information, skills and inspiration to implement the shared reading program and establish at least one book club.
