6. General Business

6.1 Respectful Relationships Brimbank Melton – G Cabezas

G Cabezas and N Poljak attended the meeting as guest presenters to share information about the Department of Education and Training's Respectful Relationships program. The program is a whole of school approach to respectful relationships which forms part of the Victorian school curriculum for Foundation through to Year 12.

The program is being delivered across Victoria, stemming from recommendation 189 of the Royal Commission into Family Violence. It is the largest prevention initiative to be funded, commencing in 2017 with funding secured until June 2020. Five schools in the City of Melton have already delivered the program, with another nine schools confirmed for 2019-20.

Professional development is also being offered to early years educators to reinforce the program's messages in state funded kindergartens. Two of Council's Preschool Field Officers will attend this training.

The presentation and contact details will be shared with the Committee.

6.2 Support and Safety Hub advocacy - L Smith

L Smith shared that Council is continuing to advocate for an Orange Door to be located in the City of Melton. Advice has been sought about the types of office space that Family Safety Victoria are seeking.

6.3 16 Days of Activism Against Gender Based Violence – L Smith

Councillors have demonstrated interest in implementing a number of public installations to raise awareness during the 16 Days of Activism. The three installations, are a tree of hope, video, and decals.

Members are invited to participate in developing a slogan/message for the decals and to feature in the video.

6.4 Equality and Respect 2030 Strategy - L Smith

L Smith reminded members of the action that was nominated by the Committee for the Equality and Respect 2030 Strategy, which was to hold a business breakfast to engage local businesses in the prevention of violence against women. L Smith gauged interest levels in progressing with this initiative as a Committee. Members queried the ongoing capacity to support local businesses after a one-off event. It was suggested to tap into an existing business event where an initial presentation could take place prior to a standalone event such as Venture Melton or the Business Awards.

7.1 Member reports

Melton City Council

C Levy shared that the Melton Family Violence Network recently met and that membership is strong.

C Reid shared what Council's Families and Children department is currently delivering in regards to family violence. The department now has a family violence policy and procedure in regards to the information sharing scheme.

Victoria Police

K Anderson shared recent statistics of reported incidents of family violence within the City of Melton. He also reported that all members are undertaking an e-learning package and a half day of family violence training. iPads are now available for all members which will assist with completing L17 forms.

MiCare

R Phillips provided an overview of her case work role at MiCare where she is based in Melton two days a week. She shared that she is always on the lookout for content that can be shared with her local Burmese playgroup, especially in regards to family violence and respectful relationships.

Women's Health West

L Falconer shared that the Preventing Violence Together partnership is looking to do some new actions focusing on the collective impact across the western region. One of the actions will focus on community conversations to share key messages in regards to gender equity and the prevention of violence against women in settings such as sports clubs and early years.
