



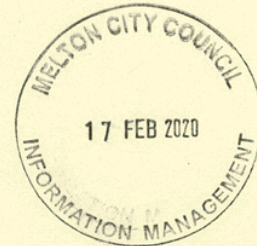

Dear Cr Carli

Thank you for your correspondence dated 13 December 2019 regarding Melton City Council's Advocacy Priorities for the 2020-21 State Budget. The Andrews Labor Government has been proud to support the Melton region's educational needs since coming to office. The following is a brief outline of some of the major investments we have made to provision for the municipality's projected population growth.

\$54.7 million for the construction of new schools, including:

- \$35.3 million to build Springside West Secondary College
- an initial \$13.8 million to build Burnside Primary School, with a further \$5.6 million later provided for construction costs for additional facilities.

\$26.6 million for upgrades and improvements to existing schools, including:

- \$5.4 million to upgrade Melton Specialist School
- \$2.5 million to upgrade Melton Secondary College
- \$1 million to refurbish classrooms and facilities at Kurunjang Primary School, as well as \$2.4 million to build a community hub at the school as part of the \$50 million Shared Facilities Fund
- \$2 million for refurbishments at Catholic Regional College Melton
- \$730,000 to build four new classrooms at St Anthony's School in Melton South
- \$997,500 for upgrades at Gilson College, Taylors Hill
- \$500,000 to build a performing arts facility at Catholic Regional College Caroline Springs
- \$151,000 for refurbishments at Diggers Rest Primary School
- funding for new classrooms at Melton West Primary School to help address enrolment pressures created by the municipality's expanding population.

\$604,500 to support students with special needs through the Inclusive Schools Fund, including:

- \$200,000 for a sensory garden at Arnolds Creek Primary School
- \$200,000 to build an outdoor sensory area at Melton Specialist School
- \$181,500 to build engaging nature-based outside learning stations at Diggers Rest Primary School
- \$23,000 to create inclusive learning spaces at Rockbank Primary School.

\$1.68 million for early childhood education, including:

- \$790,000 to build Aintree Children's and Community Hub, an integrated children's centre
- \$350,000 to upgrade early learning facilities at Diggers Rest Kindergarten
- \$539,573 to upgrade early learning facilities at Al Iman College, Melton South.

Work is continuing to ensure that Melton is equipped with the sufficient workforce and facilities for the roll-out of Three-year-old kinder in the municipality in 2022.

Additionally, the following projects are either in the planning or construction stage:


- new primary schools planned for Melton South, Eynesbury, Deanside and Rockbank North
- a new secondary school planned for Cobblebank
- \$6.2 million to upgrade Exford Primary School
- \$6.4 million to upgrade Melton West Primary School
- \$4.7 million to build a new school hall at St Anthony's School in Melton South
- \$1.6 million to support Melton City Council to build Fraser Rise Children's and Community Hub
- \$1.7 million to build a new kindergarten in Eynesbury
- \$650,000 to build a new early learning centre at Gilson College, Taylors Hill
- \$650,000 to plan upgrades to Staughton College.
