- a) have the DAC or the DAC chairperson have the opportunity to meet the judge prior to the judging process commencing.
- b) revert back to the previous process whereby businesses can nominate and apply for the "Access and Inclusion" award as a stand-alone category award, rather than the current process where only finalists are considered for this award.
- c) add a brief and clear introduction explaining the Access and Inclusion Award at the start
 of the application form.
