### 6.2 3 year old funded kindergarten planning update

### Brendan Ball, Manager Families and Children, Melton City Council

B Ball acknowledged the kindergarten providers for their continuous work with the three year old kindergarten planning.

Council's new Kindergarten Central Enrolment policy is in place ready for the intake of three year old kindergarten for 2022. This policy is aligned with the Central Registration Enrolment Scheme (CRES).

New Kindergarten Engagement Officer will be commencing on 28 January. Their role will be to identify children who are disconnected or not engaged within kindergarten and support them to re-engage.

Council has been working with kindergarten providers to allocate additional rooms to support extra sessions needed with the increased demand from the free funded 3 and 4 year old kindergarten.

### 6.3 Best Start update

### Karen Curson, Coordinator Early Years Partnerships. Melton City Council

The Best Start Annual Report was sent to the members as an attachment with agenda for today. As the Committee is the governing body of the Best Start Program, K Curson explained she was seeking endorsement of this report before submitting to the Department of Education and Training. K Curson asked the Committee if there was any feedback for the report, none was reported.

### 6.4 DET update

# Dannielle Wilson, Early Childhood Performance and Planning Advisor. Department of Education and Training

Free kindergarten announcement for sessional kindergarten for \$2000 per child, this amount is also available for children in long day care as a fee off set. \$1600 per child has been allocated to unfunded 3 year old kindergarten.

Early Start Kindergarten (ESK) eligibility has been extend to include refugee and asylum seekers families, further information on this has yet to be released.

COVID-19 eLearn -modules are available for all early childhood education and care teachers, educators and staff on the online platform FUSE, the modules provide facts, practical strategies and information about precautions that can be taken to reduce risk while at work.

School Readiness Funding (SRF) plans are currently being reviewed by the Early Childhood Improvement Branch.

A Learning from Home survey has been developed. Families with children attending 3 or 4 year old kindergarten are being encouraged to complete the survey.

### 6.5 DHHS update

### Robert Begley, Department of Health and Human Services

R Begley stated to the committee if anyone had feedback on the report provided or wanted any additional information he was happy to include, if possible, in future updates.

An overview was provided in reference to the number of children and young people engaged with Child Protection.

At this present time, there are 31 vacant practitioner positions, which is providing a significant strain on workloads, ability to progress cases and staff morale. This number has been impacted by university's reducing the number of international students and a significant influx of investigations sent through by the intake team.

The Secretary of the Department of Health and Human Services can authorise an Aboriginal and Torres Strait Islander controlled organisation to take on the care of Aboriginal and Torres Strait Islander children where this is in the best interest of the children, there has recently been a family where the care of the children has been transferred to VACCA (Victorian Aboriginal Child Care Agency).

Currently trends within the last six months noticed by Child Protection practitioners have been Family Violence incidents and substance misuse. There have also been an increase of services making a report to Child Protection because they were unsure of a situation due to COVID-19 restrictions

J Weber asked about the present number of unborn reports, R Begley confirmed there were currently 16.

### 6.6 NDIS update

### Matthew Boyd, Brotherhood of St Lawrence

The Brotherhood of St Lawrence is Local Area Coordinator (LAC) for the NDIS within Melton.

The NDIS begun in Melton two and a half years ago, the initial focus has been working through the backlog of existing Early Childhood Intervention Services (ECIS) referrals, the current wait time from initial referral to engagement is generally under a month. Recruitment for vacant staffing positions is underway.

An NDIS Early Childhood Intervention reset was announced in 2020 to consider how services can be delivered more in line with the way that was intended. A Discussion Paper explores how the NDIS is currently working, noting a lot of benefits and some challenges in areas where there is limited access to providers and clients are waiting for private providers in a 'thin' market, such as in Melton. Other information includes stretching eligibility up to the age of 9



years old and how NDIS can help support vulnerable families to develop a plan and access services within it.

# 6.7 Melton City Council Families and Children Update – what is coming up in 2021 Brendan Ball, Manager Families and Children, Melton City Council

Conversations and work has begun with the immunisation team to define what local governments role will be if any with the roll out of the COVID-19 vaccination.

In April, Supported Playgroup will become part of the Information Sharing Schemes as Information Sharing Entity (ISE). Work is underway to bring the Supported Playgroup team in line with Council's existing ISE's.

Kindergarten Central Enrolments are preparing for the roll out of 3 year old kindergarten registrations for 2022 that will open in March 2021

### Discussion continued - service gaps for children under three

G Callander reintroduce the topic of the service gaps for children under three, which was discussed at the last meeting. Interest in formation of a working group was identified, with a focus on targeted engagement of the most vulnerable children under 3 years of age.

Common themes from the previous meeting

- increased Family Violence reports to police
- increased referrals to Brotherhood of St Laurance in December
- transportation, need of material aid, language barriers, system gap for children under three.

J Weber had an initial discussion with N Smith and developed an initial plan around arranging pop up support including material aid at kindergarten venues.

Discussions were held about under three year old services not communicating well with each other to support the families they are working with. Further discussions needs to be held in regards to how can we make the families journey through services and support easier for them and supporting organisations to work together.

M Boyd noted that families within this cohort are taking the longest time to become area of and access supported. B Ball discussed the issue of working with certain families and supporting them to avoid falling further into vulnerability and suggested and interim title of the 'First 1000 Days Project'.

K Curson and C Owens identified that there will be no duplication with the Vulnerable Children's Working Group (Best Start Program) or the Babaneek Booboop Early Years (BBEY) Project respectively and agreed that this work would enhance the Best Start program and BBEY Project.

Agreement from the members of the committee that there is value in this and will continue to explore this project. Any additional members who are interested can contact K Curson. C Reich expressed an interest in joining. Following up from last meeting K Curson will speak to S O'Kelly regarding the project.

B Ball suggested this to be a standard item on the agenda, all members in agreeance to add as a standard item. J Weber thanked all in attendance for being open to exploring this matter further.
