6. General Business

6.1 Program Overview for 2021-22 (M McClelland)

M McClelland provided an overview of key program areas for 21-22: public art projects, exhibitions, arts learning program, artist development, and cultural community development projects. Feedback was invited from the committee regarding:

- exhibition themes for group exhibitions (suggestions: community stories; wellbeing messages; Council strategies; creative methodologies)
- application call-out processes (suggestions: a specific call-out for curators, community groups, and artists rather than a generic exhibition call-out; alternative ways to do Eols)
- external curators/emerging artists (suggestions: working with students/young people; incentives to support emerging creative producers; schools exhibitions/competitions; local arts show; investigate a creative ecology study as per Moorabool example)
- artists in residency programs (suggestions: working with schools, sporting groups)

6.2 Street Art and Temporary Public Art Commissions Report (S Zymantas)

S Zymantas provided a report on street art and temporary public art commissions in development this year:

- Street activations in Melton South with residents
- Caroline Springs Lake Temporary Art Activation led by artist, Luciano, working with Creekside Secondary College students to tell stories in printed illustrated decals around Lake Caroline.
- Powerbox artworks in Melton South, Taylors Hill, Burnside Heights and Harkness

6.3 Permanent Public Art - Linear Park and Fossils of Western Plains Project Update (M McClelland)

M McClelland reported that Fossils of Western Plains has been installed (Bungaree Track, Burnside). This is a replacement set of 5 bronze 'fossils' sculptures that were stolen. Linear Park commission is now at request for quote stage. A concept for this work is planned for presentation to the Committee at the next meeting.

M McClelland distributed the current exhibition brochure and provided an overview of upcoming exhibitions.
