




Budget Special edition and Year in Review





The City of Melton is a great place to live, work and play, and Council continuously strives to make life better and safer for our residents and visitors alike.

It's budget time, and with the City of Melton now the fastest growing municipality in Australia, it's more important than ever to deliver the high-quality infrastructure, programs, services our community needs to thrive.

We have focussed on strengthening our community by maintaining and upgrading existing assets, as well as preparing our City for the future with new infrastructure to support increasing development and population.

This budget demonstrates Council's continued commitment to responsible governance. As such, it has been framed around an average rate increase of 3.25 per cent, which is below the State Government's rate cap amount for this financial year.

This financial year, our Capital Works Budget will total \$114.35 million and include roads (\$29.4 million); recreational, leisure and community facilities (\$14.1 million); footpaths and cycleways (\$6.2 million); bridges (\$2.9 million); street tree planting program (\$500,000); street lighting improvement program (\$231,000); and park upgrades and improvements (\$14.2 million).

An \$85 pensioner rebate will again be available to eligible property owners.

Once again, community consultation informed Council's 2023/2024 budget deliberations, so I'd like to extend my thanks to everyone who shared their ideas and visions for our City with us.

Your local knowledge and insights have been invaluable, enabling us to prepare a budget that's not only fair and equitable, but also strives to achieve the timely delivery of infrastructure, programs, and services for our community.




Kerbside bin collections

Household waste, green waste and recycling is managed through kerbside bin collection, with various bin sizes and combinations available to choose from.

If you are receiving a Council kerbside waste collection service, including both tenants and owners, you can access waste entitlements:

Two hard waste collections up to 3m³ from within your property boundary. Bookings essential. Visit **melton.vic.gov.au/hardwaste**

OR

Two visits to the Melton Recycling Facility with a car or trailer up to 1m³. Access for ratepayers is available by scanning your rates notice or quoting your Rates Assessment Number. Residential tenants can access these options by applying in advance. Proof of residency is required.

OR

One visit to the Melton Recycling Facility and one At Home hard waste collection.

Rates: Your questions answered

Each year Council determines the amount of rate revenue needed to deliver key services, programs, facilities, parks, and other community infrastructure.

How are my rates calculated?

Rates are calculated on the Capital Improved Value (CIV) of your property. This means the combined value of your land and all improvements to the property. State legislation requires properties to be valued on a common date every year. All properties were valued as at 1 January 2023.

For any questions regarding your property valuation, contact Council's Revenue department on 9747 7200.

What are the other charges on my notice?

Municipal Charge – \$160 is applied to each rateable property to recover part of the administrative costs of operating Council.

Waste Management Charge – a flat rate of \$319 is payable for waste disposal. This fee covers kerbside waste collection and disposal, and household waste entitlements.

Fire Services Property Levy – Council is required by the State Government to collect the Fire Services Property Levy via your rates and remit the payment to the State Government. The charge is made up of two parts, a fixed charge on each property and

a variable charge based on your capital improved value.

<u>Capital</u> Projects update



Diggers Rest Recreation Reserve



By the end of 2023, Diggers Rest Recreation Reserve will have a new multipurpose sports pavilion, and community facility, a redeveloped oval, new cricket nets, electronic scoreboard, more car parking, and new access road.

The new pavilion and community facility will be centrally located at the reserve and will replace three aged buildings that are no longer fit for purpose and will serve as a hub for the Diggers Rest community and fast-growing local sporting clubs.

Turf for the oval has been laid and has shown early signs of root growth. This type of grass will go dormant over the winter months and will need time to fully establish in spring.



The cricket nets have progressed well, with the concrete having been poured and the synthetic turf laid.

The new carpark and access road are progressing well and once these are complete, the cricket nets will be available for use.

The steel structure of the pavilion is also in place for both the north and south buildings. Roof installation and wall cladding will commence shortly, so the building will start to take shape. The balconies to the east and west are in place and will provide great viewing to both ovals.

Council has invested \$8.2 million in delivering these upgrades, supported by an additional \$4.1 million contribution from the Victorian Government.

Bridge Road extension



Works have begun on the new extension to Bridge Road in Cobblebank, between Ferris Road and Adelong Boulevard.

The \$10 million project, which will link the Atherstone and Robinsons Rise estates, will provide access to the future Melton Hospital, expected to open in 2029, and to the St Francis Catholic School, the construction of which is near completion.

The roadworks will include an 830-metre extension to Bridge Road between Ferris Road and Adelong Boulevard, the upgrade of the intersection at Ferris Road to a signalised intersection, the extension of all services and associative works surrounding the area on Ferris Road.



We expect minimal disruption to residents, motorists and the community during the construction works. The latter part of construction will also include the signalisation of the Ferris Road and Bridge Road intersection. The Bridge Road extension is scheduled to be completed by mid-2024.

The Victorian Government has contributed \$620,000 to the project to support sewerage and conduit works required to service the Hospital.
