By participating in the StoryWalk® **Competition**, you, the Entrant, agree to the below Terms and Conditions:

1. The Competition opens at 12:01am Sunday 1 December 2024 and closes at 11.59pm on Sunday 2 February 2025. This competition can be accessed by completing the survey via <https://www.surveymonkey.com/r/W9G6WVP> or by scanning the QR code on the StoryWalk® page at [Hannah Watts Park](#) and [Lake Caroline Reserve \(CS Lake\)](#).
2. This competition is open to all ages. Entrants under the age of 18 must have the express consent of their parent or guardian to enter. The parent or guardian must accept these terms and conditions on behalf of the Entrant to enter.
3. Melton City Libraries has no obligation to accept late, lost, or misdirected entries.
4. Only one entry per person will be accepted.
5. Employees of Melton City Council and their immediate family members are not eligible to enter.
